- All bills received have been paid. However, there are still more bills coming in as the fiscal year is coming to an end. All check requests are due to the treasurer by February 15 so that the amounts can be included in the final report for this fiscal year.
- The CPA has stated that the deposit forms may be destroyed each month after the monthly report has been made. Check requests need to be kept for 5 years.
- State Farm has paid a total of $\$ 90.86$ on the 3 CD's over the past year. The bond funds have each averaged $\$ 80$ - $\$ 90$ monthly. Monies invested in the bonds are in diversified funds.

Vice President/By-Laws: Marie Morris
- The decision was made to conduct the voting for the new slate of officers by having members stand to vote. No paper ballots will be used.
Endowment/Donations: Carolyn Moser
- There is no new report at the time.

Quilt Show: Mary Bazzano/Donata Pfisterer/Kathy Zimmer

- The Quilt Fiesta made $\$ 12,000$ more than last year's show.
- Attendance at the door was $4,932.181$ members paid $\$ 5$ to attend the show. Attendance was about the same as last year.
- Attendance on Sunday was only 730. A suggestion was made that the Quilt Fiesta committee consider holding a Small Quilt Auction on Sunday afternoon with quilts donated by the membership.
- TCC said that we were one of the few groups that actually made money this year.
- 2 Co-op participants, Marianna Dodson and Connie Stephens came to the business meeting to express their thanks for the change from Boutique to Co-ops this year. Both members said they were glad to be in a Co-op and felt they had done very well with their sales.
- All Guild mugs have now been sold or given away as door prizes.
- Approximately 60 Block of the Month pattern sets were sold at the show.
- Moving the Bed Turning worked out well.
- Both Margaret Miller and Bobbie Aug complimented our show, saying it was the best Guild show in the country.
- The decision was made to continue to use the cash register for patterns, pins, and DVD sales and to work to improve the process.
Membership: Colleen Babcock
- The membership count for 2010 was 698 total, we had one of these members resign and 3 deaths this year, for a final count of active members of 694. The Quilt Show was a great success for membership. We had 26 new members join as a direct result of the quilt show, nine renewals for members that were not active in 2010, and twenty-nine 2010 members renewed for a total of sixty-four 2011 memberships.
- We sold 17 badge holders during the show.
- The Membership sign needs to be updated. The cost for a new sign is $\$ 130$. Colleen has this money still left in her budget and so will have a new sign made, this one without specific amounts for dues; the statement that dues include free admission to the Quilt Fiesta will also be removed.

- February: Hollis Chatelain - Both workshops are full.
- March: Peggy Martin - 7 spaces remain open in each workshop.
- April: Sue Benner - Both workshops are full.
- May: Suzanne Marshall - 7 spaces are open on Friday, 13 are open on Thursday.
- June: David Taylor - 6 spaces are open on Thursday, Friday workshops are full.
- Joline is in discussion with Cindy Brick to fill the October opening. Cindy specializes in Crazy quilts and other historical quilting.
- The Program Chair from the Sierra Vista Guild asked Joline about having Suzanne Marshall as a guest speaker on the Monday of the week that she is coming to Tucson. However Sierra Vista does not have the money to share the airfare costs for her flight from St. Louis to Tucson. It was suggested that since her workshops are not full that the interested Sierra Vista members should come to Tucson to take her classes. The board did not vote to allow Sierra Vista to have Suzanne as a guest speaker on the same trip without contributing to her airfare.

- Sue Franklin had no new comments.
- Nancy Landon had a member complain that everyone she talked to was unhappy with the elimination of the boutique. This member also said she was not aware of the opportunity to join a Co-op at this year's show.

- The new set of blocks for the fiscal year 2011/2012 is called 'Color the Year with Quilts'. About every other month there will be a special project to make with the BOM pattern. This project will be available in the newsletter on the website, and patterns may be picked up at the BOM table.
- The block for March is called Let's Go Fly a Kite. The pattern uses a faced appliqué technique.
- David Kuskulis suggested that since the special project for this block requires 3 blocks that the BOM committee only give the winners 3 block. This way more members could win blocks. No decision was made about this suggestion.

It has been decided that the batik fabrics will be sold to guild members with proceeds from the sale to be used to purchase batting. Margaret will conduct the sale on Tuesday night, and Mary will sell on Wednesday morning.
- 60 quilts from the quilt-a-thon this year will be donated to Kids in Need. This organization is supported by our CPA and she requested the quilts.
