#### Old Business:

• Cathy Dargel reported on the July 21 meeting of the Tucson Visual Arts Center. She told the group present at that meeting that TQG requires 360 square feet of storage space and 900 square feet of office space, both dedicated for the sole use of TQG. They also require 1200 square feet for workshop space and 4000 square feet of meeting space. This space can be shared but TQG will need 1 week per month (the week which includes the second Wednesday of the month).

The group decided to disapprove the inclusion of retail sales in the space, as this would triple the cost of the building.

There were 10 different groups represented at the first meeting. The next meeting will be near the end of August. The governing structure is undetermined at this time. Cathy noted that, as the largest and most financially secure organization, TQG support will be necessary for the continuation of the group.

#### **New Business:**

- Christine McCollum is planning a quilt raffle in October and November to benefit the Community Food Bank. There will be two quilts--one for the night meeting and one for the daytime meeting. Tickets will be \$1 or 6 for \$5. Cathy Dargel moved to permit sales at the October and November meetings. The motion was seconded by Sally Dickinson and passed.
- Members Marie Carmean and Paulette George attended the board meeting, representing Desert Springs Baptist Church. Their group does sewing projects for charity. A young member of their

congregation has spinal muscular atrophy--a genetic disorder that prevents movement. They are raffling a quilt, with the money going for his treatment. They would like to sell tickets at our September and October meetings (\$1 or 6 for \$5). Colleen Babcock moved to allow these sales. The motion was seconded by Joan Swanson and passed.

The meeting was adjourned at 10:24 a.m.
