The Show meeting in August went well. They showed the block from the 2019 quilt. Kits are being prepared to be handed out.

In February the General Meeting will be on the day that is usually the Business Meeting (first Wednesday and the night before) so that quilts for the show can be turned in at the General Meeting.

After the Business Meeting, the Chairman met with Gayle Petrillo, the Development Director for SAACA. They have accepted the Guild's membership and Cathy has requested that they change the physical address they have on file for the Guild, to the Guild's PO Box. The group has the Guild's website and Cathy is preparing publicity for their publication.

SAACA is moving to a new location but the address is unclear at this time. Ms. Petrillo did state that the new facility would accommodate the Guild General Meetings and, as a member, we would be able to meet there. No mention of fees was discussed.

There will be a Festival of the Arts in December that we can participate in, as well as many other opportunities.

VTAT is going to participate in one of SAACA's sales events, and the Guild might be able to sell things if there are volunteers.

Ms. Petrillo asked for a quilt that could be used in a raffle they are having in September for Jazz Legends Live. Cathy had finished one called Jazz Attack and donated the quilt to SAACA on behalf of the Guild.

### **Organizations:**

***Quilt for a Cause*** -- The memorial for Jeannie Coleman was very nice. There was some talk of developing a Memorial Fund in her name, perhaps a Medical Professional Scholarship Fund to train nurses. No decisions have been made. The three new board members have taken their seats.

The Quilt Show committee has been asked to set up a ribbon for a Best Wearable Art award in Jeannie's honor.

***Quilters Hall of Fame*** – The Tucson Quilters Guild currently has no representation on Board of the Hall of Fame as this time. The board is down to three individuals and currently meets in Phoenix since that is where the Board members live. Cathy Dargel will be submitting a request to fill this position in the Opportunity Knocks column in the newsletter.

### **Quilt-a-Thon: Barbara Heiman**

Eighty-five quilts were finished at the Quilt-a-Thon. A few more are coming in over time. Attendance was up from last year. The Guild already has 86 ready for next year, plus a lot of extra supplies. An e-mail was sent out letting members know when the quilts will be delivered to Interfaith Community Services which will be September 8<sup>th</sup> at 10 am.

### **Quilting for Others: Mary Meserve / Kathy Harris**

The Chairman has received calls regarding donations to the survivors of Hurricane Irma in TX. Mary has said that they don't need quilts or supplies – the most desperate need is for money. A suggestion was made to donate the raffle proceeds to the Tucson Community Food Bank. An article will be put in the newsletter requesting no quilts or supplies.
